INDEPENDENT AUDITORS' REPORT

To the Board of Directors
Rebuild Local News, Inc.
Brooklyn, New York

Opinion

We have audited the financial statements of Rebuild Local News, Inc. (a nonprofit organization), which comprise the statements of financial position as of December 31, 2024 and 2023, and the related statements of activities, functional expenses, and cash flows for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of Rebuild Local News, Inc. as of December 31, 2024 and 2023, and the changes in its net assets and its cash flows for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Rebuild Local News, Inc. and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Rebuild Local News, Inc.'s ability to continue as a going concern for one year after the date that the financial statements are issued.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

NOTES TO FINANCIAL STATEMENTS

As of and for the Years Ended December 31, 2024 and 2023

1. Nature of Operations:

Rebuild Local News, Inc. (the Organization) is a nonpartisan, nonprofit organization that advances public policies to counter the collapse of local news, revitalize community journalism, and strengthen democracy. The Organization was incorporated in the State of Delaware in September 2022. In January 2023, it became independent of its founding organizations, the GroundTruth Project and Report for America.

2. Summary of Significant Accounting Policies:

These financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, with the more significant of these principles described as follows:

Cash and Cash Equivalents

The Organization's cash and cash equivalents, as stated for cash flow purposes, consist of interest and noninterest-bearing cash accounts. The Organization considers all short-term investments with an original maturity of three months or less to be cash equivalents.

Intangibles

The Organization capitalizes intangible assets greater than \$5,000 and amortizes them on a straight-line basis over a period of three years.

Financial Statement Presentation

The Organization reports information regarding its financial position and activities according to two classes of net assets: net assets without donor restrictions and net assets with donor restrictions.

Net assets without donor restrictions - Net assets that are not subject to donor-imposed restrictions and may be expended for any purpose in performing the primary objectives of the Organization. These net assets may be used at the discretion of the Organization's management and the Board of Directors.

Net assets with donor restrictions - Net assets subject to stipulations imposed by donors and grantors. Some donor restrictions are temporary in nature; these restrictions will be met by the Organization's actions or by the passage of time. Other donor restrictions are perpetual in nature, whereby the donor has stipulated the funds be maintained in perpetuity.

Advertising Costs

The Organization expenses advertising costs as they are incurred. Advertising costs incurred for the years ended December 31, 2024 and 2023, amounted to \$7,358 and \$5,298, respectively.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Uncertain Income Tax Positions

The Organization has determined that it has no uncertain income tax positions as of December 31, 2024 and 2023. Also, the Organization does not anticipate any increase or decrease in unrecognized tax benefits during the twelve months that would result in a material change to its financial position. The Organization's income tax return for the year ended December 31, 2023, remain open for examination.

Uncertain Income Tax Positions (Continued)

The Organization includes interest and penalties in the financial statements as a component of income tax expense. The Organization has no tax penalties or interest reported in the accompanying financial statements.

Revenue Recognition

The Organization accounts for contributions in accordance with Accounting Standards Codification (ASC) 958-605, *Accounting for Contributions Received and Contributions Made*. Contributions, including unconditional promises to give, are recognized as revenues in the period received. Contributions received are recorded as an increase in net assets without donor restrictions or net assets with donor restrictions depending on the existence and/or nature of any donor restrictions. Contributions that are restricted by the donor are reported as increases in net assets without donor restrictions if the restrictions expire (that is, when a stipulated time restriction ends or purpose restriction is accomplished) in the reporting period in which the revenue is recognized. All other donor-restricted contributions are reported as increases in net assets with donor restrictions, depending on the nature of restrictions. When a restriction expires, net assets with donor restrictions are reclassified to net assets without donor restrictions and reported in the statements of activities as net assets released from donor restrictions.

The Organization uses a present value discount on its long-term grants receivable. The Organization uses the yield rates provided by the U.S. Treasury at the time the receivable is recognized.

The Organization also receives certain grants that are subject to certain barriers that preclude the Organization from recognizing grant revenue at the time the funds are awarded. These grants are treated as conditional contributions, and the related grant revenue is recognized when the barrier has been satisfied, which is generally when the related expenses have been incurred by the Organization.

The Organization offers membership tiers and recognizes these memberships in accordance with ASC 606, *Revenue from Contracts with Customers*. Members receive access to other professional associations interested in the health of local news, among other benefits. The performance obligation is satisfied over time as the services are provided throughout the membership period. Memberships not yet satisfied by the end of the fiscal year remain in deferred revenue. As of December 31, 2024 and 2023, the Organization had \$3,063 and \$8,813, respectively, in contract liabilities.

3. Concentration of Credit Risk:

The Organization places its cash and cash equivalents on deposit with financial institutions insured by the Federal Deposit Insurance Corporation. Deposits held in noninterest-bearing transaction accounts are aggregated with any interest-bearing deposits the owner may hold in the same ownership category, and the combined total is insured up to at least \$250,000. During the year, the Organization from time to time may have had amounts on deposit in excess of the insured limit. As of December 31, 2024, the Organization had \$1,539,813 in excess of the insured amount.

8. Functional Allocation of Expenses:

Management and general expenses include those expenses that are not directly identifiable with any other specific function but provide for the overall support and direction of the Organization.

9. Income Taxes:

The Organization qualifies as a not-for-profit corporation pursuant to the provisions of Section 501(c)(3) of the Internal Revenue Code. Under this section, the corporation is exempt from income taxes on its non-business-related income, and files information returns only.

10. Subsequent Events:

The Organization's management has evaluated all subsequent events through July 1, 2025, the date the financial statements were available to be issued.

No subsequent events have been identified that would require adjustment of or disclosure in the accompanying financial statements.
